Opening remarks by Michael Møller, Director-General of the UNOG

Panel discussion moderated by Ghida Fakhry, international broadcast journalist

- **Valerie Amos – Former Under-Secretary General for Humanitarian Affairs**

Valerie Amos is the former Under-Secretary-General for Humanitarian Affairs and Emergency Relief Coordinator of the United Nations Office for the Coordination of Humanitarian Affairs. She was also the United Kingdom's High Commissioner to Australia. She has been a long time campaigner and advocate on human rights, social justice and equality issues.
- **Teresita Quintos Deles – Presidential Adviser for the Peace Process in the Philippines**

Teresita Quintos Deles was the first woman to be appointed as the Presidential Adviser for the Peace Process in the Philippines in 2003, and was later reappointed by President Benigno Aquino, Jr. in 2010, when the Philippines became the first country in Asia-Pacific to adopt a National Action Plan on United Nations Security Council Resolution 1325 for Women, Peace and Security.
- **Alicia Bárcena Ibarra – Executive Secretary of ECLAC**

Alicia Bárcena Ibarra of Mexico currently serves as Executive Secretary of the Economic Commission for Latin America and the Caribbean (ECLAC). Ms. Bárcena Ibarra served as the Chef de Cabinet to former Secretary-General Kofi Annan before serving as the Under-Secretary-General for Management.
- **Major General Kristin Lund – Force Commander of the UNFICYP**

Major General Kristin Lund of Norway is the Force Commander of the United Nations Peacekeeping Force in Cyprus (UNFICYP). Major General Lund has had a distinguished military career, with more than 34 years of military command and staff experience at the national and international levels.
- **Elisabeth Rehn - Member of the Board of Directors of the ICC Trust Fund for victims**

Elisabeth Rehn is a member of the Board of Directors of the International Criminal Court (ICC) Trust Fund for Victims in The Hague and of the UN Women High Level Advisory Group for the Global Review on the 15 years of implementation of Security Council Resolution 1325. She was Finland's and the world's first female Minister of Defense between 1990 and 1995.
- **Mary Robinson – President of the Mary Robinson Foundation – Climate Justice**

Mary Robinson is President of the *Mary Robinson Foundation – Climate Justice*. She served as President of Ireland from 1990-1997 and UN High Commissioner for Human Rights from 1997-2002. She is a member of the *Elders* and the *Club of Madrid* and the recipient of numerous honours and awards.
- **Dr. Paul Williams, President of the Public and International Law & Policy Group**

Dr. Paul Williams is the Rebecca Grazier Professor of Law and International Relations at American University. Dr. Williams is also the founder and President of the Public International Law & Policy Group. During the course of his career, Dr. Williams has assisted over two dozens states and governments in major international peace negotiations.
